<b>Checklist for Schengen Visa: FAMILY AND FRIEND VISIT</b>		<b>YES</b>	<b>NO</b>
1	<b>Valid passport</b> - issued within the last 10 years and with at least 3 months validity after the scheduled return, with at least two empty pages along with old passports (If not, FIR or proof of cancellation)		
2	<b>Application form</b> – completed, signed twice by the applicant. If the applicant is a minor, visa application signed twice by legal guardian (Proving the custody of a minor child, apostilled birth certificate, divorce papers etc)		
3	<b>One passport photograph</b> – not older than 6 months (35mm x 45mm) in color with white background with no software corrections.		
4	<b>Travel health insurance</b> - Valid in Schengen countries with a coverage of at least 30,000 EUR for the entire duration of stay in the Schengen area <a href="https://www.vfsglobal.com/estonia/india/pdf/Travel-Insurance-Companies-Family.pdf">https://www.vfsglobal.com/estonia/india/pdf/Travel-Insurance-Companies-Family.pdf</a>		
5	<b>Proof of accommodation</b> – <ul style="list-style-type: none"> <li>- Hotel reservations, rental of holiday home or campus residence reservation</li> <li>- If the applicant intends to stay with a family member or a friend, proof of sponsorship and/or private accommodation from the host</li> <li>- If the applicant is travelling to several Member States, proof of accommodation in each of them</li> </ul>		
6	<b>Proof of means of transport</b> – flight return tickets and itinerary ( <u>please do not buy tickets before obtaining the visa!</u> )		
7	<b>Invitation letter</b> – <ul style="list-style-type: none"> <li>- Invitation from the family member/friend, including their address and contact details, and intended period of stay.</li> <li>- Evidence of legal residence of family/friends visited in Estonia: copy of passport/national ID card, or residence permit.</li> </ul>		
8	<b>Proof of financial means</b> - All documents have to be <b>ORIGINALS</b> , in format A4. <ul style="list-style-type: none"> <li>- <u>Last 3 months personal bank account statements with stamp and signature of Bank.</u></li> <li>- <u>Personal ITR acknowledgement receipt page for the last 2 assessment years</u></li> </ul> <b>If employed :</b> <ul style="list-style-type: none"> <li>- <u>Last 3 months salary slips and last 3 months salary bank account statements (stamped and signature of the Bank).</u></li> </ul> <b>If self-employed and/or company owner :</b> <ul style="list-style-type: none"> <li>- <u>Business registration certificate / Partnership Deed / Proof of proprietorship or other proof of ownership. Last 3 months personal and business bank account statements (stamped and signature of the Bank).</u></li> </ul> <b>If retired :</b> <ul style="list-style-type: none"> <li>- Personal pension bank statement for the last 3 months (stamped and signature).</li> <li>- Proof of regular income generated by ownership of property or business.</li> </ul> <b>If sponsored :</b>		

	- proof of sponsorship and/or private accommodation (personal bank statements for the last 3 months (stamped, signature of the Bank; proof of work or ownership of business and ITR acknowledgement receipt page for the last 2 assessment years)		
9	<p><b>Children under 18 years old, not travelling with both parents:</b></p> <ul style="list-style-type: none"> <li>- Written consent letter of the other, non-travelling parent or legal guardian, certified by public notary.</li> </ul> <p><b>Children under 18 years old, travelling alone :</b></p> <ul style="list-style-type: none"> <li>- Written consent letter of both parents or legal guardian, certified by public notary.</li> </ul> <p><b>In all cases:</b> copies of the passports of both parents (legal guardian) or PAN cards.</p>		
10	<b>Students</b> - Copy of the student college ID card and introduction letter of the School/College/University.		
11	<b>Passport copy</b> of 1 <sup>st</sup> page (bio data) and last page of the passport
